A copy of page 1 of the Federal Income Tax Return (IRS Form 1040, 1040A, 1040EZ) for the year 2017 must be attached to this application including any tax returns filed by dependent children. Any parent or guardian who claims the student as a dependent must submit a copy of their 1040. If you did not file a tax return for 2017, include a signed statement of moneys received in 2017 and number of dependents you supported in 2017.

- Scholarship funds are available only at schools that donors have recommended us to support with their contribution.
